TERMS AND CONDITIONS

PAYMENT POLICY: A deposit of \$500 per person is due to secure your reservation. The balance of payment is due by July 25. After July 25, 2017 space is available on a first-come, first served basis and full payment is due with reservation.

CANCELLATION POLICY:

Cancellation fees for LAND PACKAGE per person are as follows:*

From time of reservation until July 25, 2017: \$ 300.00
From July 26-August 18, 2017: \$ 1,000.00
From August 19-September 20, 2017: \$ 1,500.00
From September 21 to day of departure: NO REFUND

Penalties apply on a per-person basis and are calculated from the date written notice of cancellation is received by AESU. *Above restrictions apply to land tour package only. Flight reservations are separate and carry separate cancellation penalties, to be detailed at the time of reservation.

All cancellations must be received by AESU in writing. Date of receipt will determine penalties assessed. No show also means no refund.
